Terms and Conditions

Please read the following information carefully as it applies to all travelers.

Reservations

Reservations can be made through your travel agent or directly with Rocamar Tours. A deposit of \$400.00 per person is required to confirm a reservation. Acceptance of the client's booking will be confirmed in writing by the company. The unpaid balance must be paid within 60 days prior to the departure date. For bookings made 60 days or less before the departure date the full amount is payable at the time of booking.

Cancellations by the client

Cancellations by clients must be made in writing (fax or e-mail) and acknowledged by Rocamar Tours. The date on which the letter of cancellation is received by the company or its agents will determine the cancellation charge applicable. Cancellation more than 60 days from the departure date, all but \$50.00 of the deposit is refundable. Cancellations between 30 and 60 days from the departure date are 50% refundable. Cancellations less than 30 days from the departure date are non-refundable. Reservations are transferable to a second party if the client is unable to participate.

Cancellations by the company

The company reserves the right to cancel a tour for any reason, but will not cancel a tour less than 45 days before departure except for unusual or unforeseen circumstances beyond the Company's control. Rocamar Tours reserves the right to cancel a trip within 45 days of departure if the tour is not guaranteed. A tour is guaranteed when there are six paying clients. Rocamar Tours is not responsible for costs paid out by the clients for non-refundable air fare or travel costs in the event a tour is cancelled.

Cancellations by the company

The Company offers no refunds or credits for missed or unused services.

Versatility

The client must appreciate and acknowledge that the nature of this type of travel requires flexibility and should allow for unexpected changes. The route, schedules, transportation and amenities may be subject to change without notice due to local circumstances, sickness, mechanical breakdown, climate or other unpredictable or unforeseeable state of affairs.

Physical activity

In order to experience as much as possible while in Mexico, our days are full, we move at a steady pace, and require a moderate level of physical fitness. All clients should be in general good health and capable of walking reasonable distances each day. The client accepts that these tours are adventurous in nature and that such vacations may involve a certain amount of personal risk. Every precaution will be taken by the Company to ensure the safety of all clients to the extent that this is possible.

Tour leaders

Our Tour Leaders are qualified outdoorsmen who will make every effort to make your experience exciting, interactive and safe. The Company's Tour Leader will make the final decision on all matters concerning the safety and well being of the tour. The client must at all times adhere to the laws of the land, customs and foreign exchange of Mexico. Should a client refuse to comply in these matters, thus interfering with the well-being of the group, the tour leader may expel any tour participant from the tour. The Company will offer no refund to clients who have been expelled.

Insurance

It is advisable that all clients have travel insurance to cover personal accident, medical expenses and repatriation expenses. It is advisable that coverage be extended to include cancellation, loss of effects and any other expenditures which may arise as a result of loss, damage, injury, delay or inconvenience to the client.

Responsibility

All arrangements outlined in the itinerary have been made by Rocamar Tours on behalf of customers. These arrangements are made on the condition that Rocamar Tours shall not be held responsible for any injury, death, accident, delay, loss or damage which may be caused by any company or person employed to carry out the arrangements and services described in the agreed upon itinerary.

The Company offers no assistance in the event that a client find themselves in a situation with the authorities of Mexico, whether it be concerning possessions (drugs, archaeological artefacts, or any other illegal possession), actions, or illegal entrance or sojourn in the country. The Company holds a no tolerance rule; the client will be left to deal with their situation personally and at their own expense. Each client will be legally considered an individual and their actions and/or possessions are therefore not the responsibility of the Company.

Rocamar Tours cannot be held responsible for any defect in vehicle, acts of God, detention delays, strike, theft, civil disturbances, accident by boat, bicycle, motor vehicle or any form of transportation or in any hotel, inn, guest house or any other form of accommodation.
